## What is Vita?

The Volunteer Income Tax Assistance (VITA) program offers free tax help to people who generally make \$54,000 or less, persons with disabilities and limited English speaking taxpayers



who need assistance in preparing their own tax returns. IRS-certified volunteers provide

free basic income tax return preparation with electronic filing to qualified individuals.

## Additional Services

CADC's Vita Tax Sites offer the following additional services:

- myRA-a free retirement savings program with no fees
- Free financial literacy
- US Savings Bonds
- Split Returns
- Debit Cards: For those who do not have a checking or savings account, may have their refund deposited on a debit card for faster service.



Earned Income Tax Credit is for people who work for someone else or own or run a business or a farm. To qualify, you must have low to mid income and meet the following rules. To qualify, you and your spouse (if filing a joint return):

- ♦ Must have earned income
- ♦ Must have a valid Social Security valid for employment issued on or before the due date of the return (including extensions)
- ♦ Cannot have investment income over a certain amount
- ♦ Generally, must be a U.S. citizen or resident alien the entire year
- ♦ Cannot file as married filing separately
- ♦ Cannot be a qualifying child of another person
- ♦ Cannot file form 2555 or 2555-EZ (Foreign Income)
- ♦ Must have a qualifying child or:
  - Be age 25 but under 65 at the end of the year
  - Live in the U.S. for more than half the year, and
  - Not qualify as a dependent of another person.

To claim the EITC, you have to file a federal tax return even if you owe no tax and are not required to file. File your tax return as soon as you have all the information you need about how much you earned. The IRS will process your tax return but may hold any refund owed to you to allow time for verifying your return is correct. EITC provides a boost to help pay your bills or save for a rainy day.

## What to Bring?

- State Issued Identification
- Social Security Cards for You, Spouse, and dependents
- Individual Taxpayer Identification Number (ITIN) assignment letter for you, spouse, and dependents.
- Proof of Foreign Status, if applying for an ITIN
- W-2's, w-2G's, 1099-R's from ALL employers
- Interest and Dividend statements from banks. (Form 1099)
- Health Insurance Statements (Form 1095A)
- Copy of Last Year's Federal and State return (If Available)
- Proof of Bank account routing and account numbers for direct deposit, such as a blank check.
- Total amount paid for daycare services with daycare provider's tax id number
- To file taxes electronically on a married –filing– joint tax return, both spouses must be present to sign the required forms.
